Public update: March 28, 2024

### **Executive summary**

This report shares data and activities directed by Unified Command for the Incident Management Team (IMT). The information in this report comes from a joint effort among the City, State and County. Please note that not all requested data is included yet, but we expect to add it as soon as it becomes available.

### **Objectives**

- Leverage the city, state and county's resources to improve livability in Portland's city center.
- Enhance coordination and accessibility of housing, treatment, and recovery services in Portland.
- Combine health, law enforcement, and other data into a countywide dashboard for better response and monitoring.
- Identify housing, health and law enforcement gaps and obstacles, then make specific policy recommendations to leaders and lawmakers for better coordination.
- Develop a transition plan to expand and improve response efforts, with focus on both short-term and long-term needs.

### Key activities/highlights this week


This includes work happening at Unified Command's direction and actions taken by partner agencies participating in the emergency declarations.

- Law enforcement, first responders and outreach workers continued to disrupt drug dealing, offer outreach to people using fentanyl in public, and respond to emerging issues in the operational area.
- The <u>Multnomah County Overdose Dashboard</u> was released at the request of Unified Command. The dashboard includes important health data related to fentanyl overdoses. The sources of the information include:
  - o Multnomah County Medical Examiner's Office records
  - o Fentanyl-related visits to emergency departments and urgent cares
  - o City of Portland's Bureau of Emergency Communications
  - o American Medical Response (AMR) ambulance responses
  - o Portland Fire & Rescue responses

The data provides useful information about overdose trends. The data in the dashboard should not be added together. Each dashboard is a different set of data and some of the information overlaps.

The Data team is working on gathering specific information for future reports, but not all of it is available yet due to legal and technical barriers. It might take 7 to 14 days before all the statistics are available.



### **Appendix: Situation Overview Maps**

The following map shows the number of confirmed /or suspected deaths within and outside of the 90-day fentanyl emergency response operational area according to Medical Examiner data (January 1, 2024-February 25, 2024; n=59 deaths). Data are preliminary and will change as investigations are finalized. Although there were a total of 68 suspected or confirmed fentanyl overdose deaths to date in 2024 in Multnomah County, complete address information is not yet available for all decedents. Because the number of fentanyl-specific deaths is small for this time period, it is not possible to show fentanyl-specific deaths in smaller geographic regions within the operational area at this time.


