

This measure authorizes Tualatin Valley Fire &amp; Rescue (TVF&amp;R) to issue up to \$122 million in bonds to finance capital costs, including:</p> <ul style="list-style-type: none"> <li>-Replacement of response vehicles reaching the end of their useable life.</li> <li>-Fire station improvements.</li> <li>-Rebuilding the King City fire station.</li> <li>-Relocating the Aloha fire station.</li> <li>-Safety upgrades for TVF&amp;R's training center where responders are trained in fire suppression, emergency medical care, technical rescue, hazardous material response, and other emergency skills.</li> <li>-Land for future construction of fire stations in growth areas.</li> <li>-Site improvements, equipment, and bond issuance costs.</li> </ul> <p>Bonds would mature over not more than 15 years and may be issued in series. Due to declining debt service on existing bonds, the measure will not increase TVF&amp;R's bond tax rate above the current rate of \$0.1415 per \$1,000 AV unless assessed property values decline. For property assessed at \$300,000, about the average in TVF&amp;R's service area, the bond cost is estimated to be \$42.45 per year or \$3.54 per month. Actual rates may vary based on interest rates and changes in assessed value.            (174 words)</p>
