- **Supplier Profile - New Mobile Number Field for Supplier Contacts:** The mobile field name has been changed to "Secondary Phone (Optional)". Please note that the general phone number field is required and this new field is optional.

- **Ability to Search for Supplier Recipients when communicating via the Q&A Board:** search process has been streamlined with the addition of standard JAGGAER search, filter, and sort functionality on the supplier selection page in the Q&A Board.

- **Improved Q&A Links in Email Notifications:** the links within emails and in-app notifications have been improved so that when users click a link, they are navigated directly to the Q&A Board question referenced by the notification.

- **Addition of Supplier Name and Submission Date to Buyer PDF Export Files:** Previously, supplier names and their bid submission timestamp were not included in event PDF export files. To ensure that this data is readily available for business processes such as event audits, in 21.1, supplier names and submission status are included as standard data in event PDF export files.
- **Early Access Participation for the New Sourcing Search Experience:** A new Sourcing Search experience is coming soon! To check out the updated look and feel,

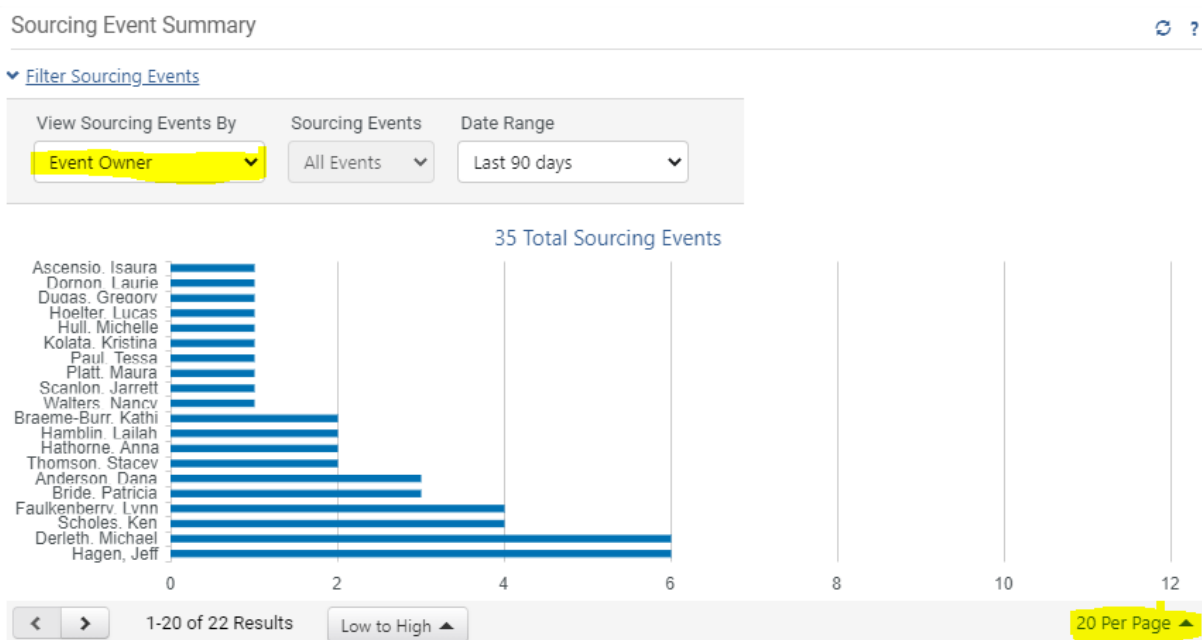

Users who opt into the new search interface can access more than a dozen new Status Flags that enable searching by such options as multi-stages, prices, scoring, and workflow. These users can also find two new Post-Search Filters that enable them to limit their search retrieval by buyer participants and assigned commodity codes. We are working on the training documents for this and will conduct testing with a group of users before rolling this out.

- The number per page has been decreased from 50 to 20 per page

- **Contract Export - New Contract Statuses Available**

Impact: increases statuses available for integration options and when running contract queries that include contract status. Previously the only statuses that would be included in a contract export were: Executed Future, Executed In Effect, Expired or Superseded. The following statuses have been added for contract exports: Terminated, Rejected and Completed.
