## **Brokerages**

- Private organizations providing case management and in-home and community-based services to individuals 18 eligible for Multnomah County Intellectual & Developmental Disabilities.
- Brokerages were established in 2001. All brokerages are governed by boards/advisory groups comprised primarily of people with I/DD and their families.
- Brokerage Personal Agents were designed to serve a very targeted segment of the population: adults with I/DD choosing to live in their own or in their family homes.

#### Adult **Supported Living** services can include:



Must live in your own house, apartment or be able to afford your own housing, utilities, food, and household supplies.

Can live alone, with family or with friends/spouse




Agencies hire the staff that are working with you.

Staff are in your home and help with daily activities like cooking, living, budgeting, bathing, taking you to appointments. The number of staff support hours are determined by an assessment



On Call staff available 24 hours per day, more support as needed for emergencies.

Living in a home with 3-5 other individuals with intellectual and developmental disabilities.



Majority of homes provide you with your own bedroom.



Cost of room and board \$617 (changes yearly) per month which covers rent, utilities, transportation to appointments and outings, 3 meals and 2 snacks per day.



Caregivers present 24 hours per day Caregivers support you according what is important to you and for you.



Home is run by employees of an organization Licensed by the State ODDS. Monitored by Multnomah County.

Majority of homes provide you with your own bedroom.



Volunteer and training activities with the ultimate goal of getting a job in the community.

#### Small Group Employment

Group of 8 or fewer individual with disabilities working in the community as part of a work crew or workgroup. Job coach on site.

## **Day Support Activities**

- Provided by an agency in a community or facility, not in a home setting
- An opportunity to meet new people and socialize
- You will be encouraged to explore interests, strengths, and abilities relating to employment or as an alternative to employment. May include volunteering when unrelated to an employment goal.
- May include community outings, and facility-based activities
- You can acquire, maintain, or enhance independence
