Individual/family must not be living in a situation where at least 50% of meals are provided (ALF, RCF, NF, hospital, etc.) Clients residing in licensed Adult Foster Homes or DD/MH group homes MAY be eligible in certain circumstances. MAGI Adult: \$1387 individual (138% FPL) \$1868 two people (138% FPL) (Pregnant Women and Children may have a different income standard)	Income that goes toward certain employment costs, along with other standard deductions, determines Adjusted Income. Adjusted income limit is \$2513 Any employed person with a disability with earned income lower than \$5111 per month automatically meets the adjusted earned income	Clients 65 years or older or determined to meet disability criteria are categorically eligible if their income is less than 185% of federal poverty level and they are given a State Resource Guide pamphlet, and these things are narrated. Income less than: \$1860.00 individual \$2504.00 Couple	OPI Fees for Service: Clients with <u>net incomes</u> between 150 and 400% of Federal Poverty Level (FPL) are expected to pay a fee toward their service, based on a sliding fee schedule. Families with net incomes above 400% FPL pay the full hourly rate of the service provided. For fee schedule consult with District Center.
