## *Viewing Assessment, Taxation and Recording Information*

Information about Multnomah County's recorded documents, property values, and taxes is available through our websites:

**MultcoRecords.com:** Recorded documents since February 2002. Search by name, date, document type, etc. The search results return the document number, type, recording date, party names and types, and legal description. Users have the ability to add recorded (non certified or certified) documents to an online cart, modify the cart, checkout, and complete payment through Point and Pay. If there are no certified items in the order, once payment is completed, the document will be made available for download. Requests for Copies of certified documents will be processed and mailed.

**MultcoProptax.com:** Multnomah County property Assessment and Tax information Search by owner, address, map, etc. [MultcoProptax.com](http://MultcoProptax.com) has a free guest log in (with limited searching); full access is available by-subscription. One sign-up covers both sites and also gives you access to purchase custom assessment and taxation data reports. You can request as many user accounts and passwords as you need.

**Searches on [MultcoProptax.com](http://MultcoProptax.com) cost 25 cents each and usage is billed annually.** We will provide a usage report by-user with your invoice.
