THIS AGREEMENT made and entered into by and between GENE SHAPER and JO ANN SHAPER, ELIZABETH HOLM and MATT A. HOLM, MARJORIE L. TABER and LEON D. TABER, MABEL DUDLEY and LEO E. DUDLEY,

WHEREAS, Gene Shafer, Elizabeth Holm, Marjorie L. Taber and Mabel Dudley are the heirs under the Will of ROSE HOWELL, deceased, which said estate has been probated in the Probate Department of the Multnomah County Circuit Court forthe State of Oregon; and
