Internship Description & Responsibilities:

The purpose of this position is to work as a team with the newly hired Immigrant & Refugee Coordinator (IRC) to further the relationships that the County enjoys with our immigrant and refugee communities in order to create and implement the county-wide I&R Project.





Under the direction of the IRC:

- Support the IRC in their duties;
- Represent the County and the Project with I&R communities, specifically through the development of a Project communications plan;
- Build and enhance relationships with I&R serving organizations;
- Define the I&R Project, create the Project plan, and work to implement beginning Project activities; and,
- Document the Project process, determine Project goals & measures, and produce Project outcome reporting.

The Immigrant & Refugee Project Intern will have the opportunity to explore what a career with the County might look like for them through:

- Supporting the creation of new programming
- Providing project management to develop, document, implement, and report on Project activities
- Experiencing what it's like to work on a high functioning team within a large County Department
