### What Does Disaster Behavioral Health Do?

Multnomah County is aware that marginalized communities face an increased risk of harm and negative consequences during & after a disaster. The disproportionate vulnerability lies at the intersection of many forms of social injustice, including economic, environmental, and racial.

Disaster Behavioral Health (DBH) is committed to ensuring that responses to disasters are informed by and responsive to historical and current barriers to access, equity and inclusion.

DBH is a program within the Community Mental Health Programs (CMHP), Behavioral Health Division of the Multnomah County Health Department. Acting as a partner to Multnomah County's Emergency Operations Center, DBH coordinates the behavioral health response to disasters in the community, such as severe weather. For example, during the activation of cooling shelters (during severe heat), DBH deploys volunteers who are able to provide caring support to both guests and other volunteers, centering whole person wellness, de-escalation, and trauma informed care.

## **Internship Description & Responsibilities:**

The DBH Volunteer Coordinator Intern will:





- Maintain the volunteer database
- Create a video with a panel of DBH volunteers, for the purposes of onboarding new volunteers
- Design a template after action report
- Collaborate with staff to create template communication plan for volunteer activation
- Coordinate the design and development of a DBH web page on the County website
- Participate in disaster activation meetings & trainings
- Other projects as opportunity & interest arise

- Connect with individuals and systems who are dedicated to serving the most vulnerable individuals & communities
