### What Does Evidence Based Practices Leads Do?

To assist with facilitating social skills building groups and bring in Evidence Based Practices to detention. To communicate and help coordinate with community partners to bring in volunteers to detention to work with youth on life skills. To help support detention as a whole in regards to scheduling, coverages, recreational activities, incentives, behavior management support to youth and extra support to staff in the units.
