The Economic Justice Project At A Glance

Background

In Fiscal Year 22, Multhomah County Board of County Commissioners funded a one-time only project to create a blueprint for action to guide future economic justice policy and investment.

This is a new area of exploration for Multnomah County. This would specifically focus on Multnomah County's unique role.

The Multnomah County Economic Justice Project Community Discussion that took place on April 29, 2023 explored and identified potential strategies for county action and investment.

What We Learned From the Research

Economic disparities are racially based and the BIPOC communities have a higher rate of poverty.

Economic Justice means promoting long-term systemic change to address the underlying issues at the roots of disparities. Although Multnomah County has made historic investments to meet existing needs, it does not currently fund programs identified as addressing the issues for Economic Justice.

The recommended Economic Justice strategies are to build assets, to build income, to repair past harms by local jurisdictions, and to eliminate barriers to wealth-building. **Feedback From the Community Discussion**

Community prioritized the following three actions for how the county could invest in economic justice strategies.

Fund basic income

Fund asset building/homeownership

Re-focus current legal system investments on mental health & wellness

Next Steps

- We will assess the feasibility of prioritized ideas and build partnerships.
- We will seek to infuse economic justice into existing county programs in the 2023-24 fiscal year.
- We will work with the Board of County Commissioners to develop proposals for the 2024-25 fiscal year.

Research and Data

About the Discussion Guide

A Discussion Guide was developed to support incorporating economic justice into the county's programs, policies, and practices. It is designed to provide the basis for a collaborative community design process to develop a blueprint for economic justice in Multnomah County.

Key Insights

Dedicating new resources toward upstream Economic Justice strategies will reduce the need over time for continued high-level investments in downstream interventions to support Economic Survival and Economic Stability.

Economic Disparities in Multnomah County



The **median income** for White households is almost **1.4 times** the median income for BIPOC households.



The **poverty rate** for BIPOC households is almost **two times** the poverty rate for White households.



The percentage of BIPOC households that have **zero net worth** is **1.5 times** the percentage of White households.



The **homeownership rate** for White households is almost **1.5 times** the BIPOC homeownership rate.



Current Investments in Economic Justice

Economic Justice

Promote long-term systemic change to address the underlying issues at the roots of disparities.

Economic Mobility

Equip people to move out of poverty and improve their economic situation by providing pathways to increased earning potential.


Economic Stability

Assist people with limited incomes to maintain their ability to meet their households' needs.

Economic Survival

Provide direct services for people whose lack of economic resources make it impossible to meet their human survival needs.

4 Strategic Recommendations


1. Strategies that build assets For example, Baby Bonds!

Small Group Priorities






What can be done differently
