The ACHP has been in the process of reviewing and planning MCAR updates since 2020.

A committee of adult care home providers met monthly over a seven month period, June 2020 through January 2021, to develop rule language suggestions. Since then work has continued internally on this project.

The last update to the MCARs went into effect in 2017.



Want to Use Digital Software to Manage Care Home Records?

Synkwise presented on "Managing Compliance of Your Home on a Digital Healthcare Platform" at the Adult Care Home Conference. Other companies provide similar digital solutions to the challenge of managing electronic records.

These platforms may improve your record keeping and help keep your care home in compliance.

Before any digital software is used, an agreement and exception need to be approved by the ACHP.

You should:

- Find the Exception Request General form at <u>Exception Requests</u>, <u>multco.us/adult-care-home-information/e</u> <u>xception-requests</u>. Submit the request to your licenser.
- Submit a statement or copy of the software company terms and agreement for review and approval before using the service.
- ACHP will review the exception and software company terms, and will then send you an Electronic Record Keeping Agreement for final approval.
- Submit the completed ACHP agreement form.

Currently approved companies are:

- Therap
- QuickMAR/PointClickCare
- Synkwise

If you are interested in using a different company, the ACHP will need their contact information. The ACHP will research the company before permitting use.

Remember, if you want to use healthcare software, all staff will need to be trained on how to use it.
