Updates From the ACHP Program Manager

Dear Providers,

I'd like to share a few updates with you, which we covered in last month's virtual provider meeting:

Medicaid Room and Board Rates: As of January 1, 2024 the room and board portion of the Medicaid payment has been set at \$733 per month.

ACHP Care Home Conference: Due to division-wide budget cuts, the ACHP will not be holding a conference in 2024.

A good way to get your annual required CEUs is by attending the ACHP in-person provider meetings. You can usually earn three CEUs per meeting.

Last year's conference relaunch was a success and my vision for the conference is to hold it every other year, budget allowing.

ODHS Surveys: Many of you completed the PSU survey, which was due at the end of January.

Two more surveys need your attention in February: the APD-ODDS Rate and Wage Survey, and a survey from the state's Office of Aging and People with Disabilities.

You'll find more information about these two new surveys in this newsletter.

I know many of you have questions about Senate Bill 99, and I will update you as soon as we have final details about requirements.

APD-ODDS Rate and Wage Survey

A survey on Medicaid reimbursement rates should be in your email inbox now. This email is from Burns & Associates, a division of Health Management Associates.

All operators should fill out the PDF survey attached to the email and return it promptly.

The Oregon Department of Human Services (ODHS) created this survey to collect crucial data. This data will be used to advocate for effective Medicaid-funded reimbursement rates for services and supports.

This survey is an essential step in evaluating reimbursement rates.

The rate and wage study is the result of direction provided during the 2023 Oregon Legislative session. A report about study results will be provided to the Joint Committee on Ways and Means or Emergency Board by the end of September 2024.

The first phase of this project began last year when the state's Office of Aging and People with Disabilities (APD) and Office of Developmental Disabilities Services (ODDS) established work groups to help inform the study process.

Caregiver Workbook and Certificate Requirements

Operators with APD or MHA residents must keep completed workbook certificates on file for all of their caregivers. Caregivers must review the Caregiver Preparatory Training Study Guide and complete the Caregiver Preparatory Training Workbook. Care home operators must keep workbook certificates on file for all their staff. (MCAR 023-090-455 [2])

- If a caregiver has completed the workbook at one adult care home, and starts working at a different home, the certificate may be transferred to the new home.
- Operators are not allowed to fill out the workbook for their staff. This is considered falsifying records and operators may face a fine. Caregivers must review the study guide and complete the workbook themselves.
- If a staff member has completed the APD Ensuring Quality Care training, they are not required to complete the caregiver workbook. (MCAR 023- 070-635)

The Oregon Department of Human Services is updating the study guide and workbook to reflect new rules. The ACHP will share the updated versions when they are available.

Required Training Due in March: Home and Community-Based Services

All APD providers, staff and volunteers in APD homes, or homes serving APD residents, must complete Home and Community-Based Services training by March 31, 2024.

I/DD and MHA operators and their staff are not required to take the training at this time, unless the home also serves an APD resident.

When you and your staff have completed the training, submit all certificates in one file to the ACHP. Certificates can be emailed, faxed or dropped off in person at the ACHP office.

Each provider will need to create or have their own individual account with Oregon Care Partners in order for the training certificate to reflect their name.

The training covers Home and Community-Based Services rights and protections. It also helps adult care home staff understand individually-based limitations and how to prepare a request for an individually-based limitation.

Your licensor's first licensing support visit in 2024 will focus on Home and Community-Based Services.
