#### What Does the Voter Education and Outreach Program Do?

The Multnomah County Elections Division conducts all local, state, and federal elections by mail for the 566,000 registered voters in our county. During this internship you will learn all the functions of a vote by mail election process.

The Voter Education and Outreach program provides education and outreach to current and future voters in Multnomah County towards: *voter registration, voter assistance resources, and voting a ballot by mail.* We deliver and assess the needs of voters through our culturally specific outreach efforts. Our efforts are directed by a racial equity lens and use a trauma informed framework to guide how we do our work.

#### Internship Description & Responsibilities:

- Attend community events to conduct voter education and outreach, focusing on preparing voters for the upcoming November General Election in Multnomah County.
- Work collaboratively with the program team and community partners to strengthen our community specific engagement plan for Black/African American voters in Multnomah County.
- Conduct workshops for community partners on: Voter Registration, Vote by Mail, and Ranked Choice Voting.
- Guide a tour of the Duniway-Lovejoy Elections Building for a community specific partner.
- Participate in the Elections Communication Team Workgroup and collaborate on the development of communication plans directed towards Voters for the November General Election.

- Learn the ins and outs of program management, equitable community engagement, and trauma informed outreach practices.
- Learn project management basics and how they are applied in public service roles.
- Learn the functions of the Multnomah County Elections Division and our responsibility to conduct all federal, state and local elections.

- Candidates should have completed at least one year of college/university studies with a focus area of: social work, civic education, political science, or other related humanities fields.

- Experience with or desire to learn public speaking and presentation skills towards diverse audiences and with an accessibility lens.
