 - Encourages visitors to think about issues within a historical context

- Interactive exhibits for kids
- Suggestion from Avel Gordly: Eliza should connect with Carolyn Leonard, Curriculum Expert
- Bittersweet Harvest: The Bracero Program (exhibit)
 - Really positive community response
 - Outreach through El Hispanic News
 - Free admission on opening day (2/18) 800 people came in on that day alone
- Publicizing free admission for Multhomah County residents:
 - Billboard to go up around Multnomah County advertising free admission
 - Suggestion: Comcast Newsmakers and bus signs (through PDC?)
- Other outreach to underserved communities:
 - OHS sends docents to low SES schools
 - OHS is hiring a new Schools Services Manager
 - Suggestion: have the LOC help with the job description for this, and look for local candidates with connections to underserved communities
 - Post cards to schools re: visiting OHS
 - Suggestion: do more outreach to community centers within Home Forward facilities
- Other information:
 - OHS will be hosting a Say Hey event (coordinating with Daryl Dixon from Multnomah County Office of Diversity & Equity)
 - Elizabeth Carroll went to OHS with members of PRSIM (Multhomah County
