### 2011 Legislative Update: A brief summary of domestic and sexual violence bills.

October 14 - Annual Judge The following is a summary of domestic and sexual violence issues addressed during the 2011 Legislative session. The session ended on June 30, 2011.

> **HB 5030:** Established the department of Human Services Budget. In this budget \$6.2 million in new funding was allocated to DHS to create a new program allowing DHS to contract with non-profit victim services providers to place domestic violence advocates at child welfare and selfsufficiency offices to provide counseling and safety services to parents who are victims. The budget also set aside funding for oversight of the program and infrastructure support to the non-profit programs across the state.

HB 2244: Exempts records of domestic or sexual violence services or resource center from public records laws. Section 6 pertains specifically to domestic violence resource centers. They were drafted to address the problem presented by the fact that the Gateway Center for Domestic violence Services in Portland, because of its sponsorship by Multnomah County (a public agency), is subject to current public records disclosure laws. The bill exempts the Gateway Center from public records laws, so that it is on equal footing with other domestic violence service providers in its ability to protect victims' records fro disclosure.

HB2940: Increases the classification of the crime of strangulation from a class A misdemeanor to a Class C felony in certain circumstances. The elevated penalty applies when (1) the crime is committed in the immediate presence of, or witnessed by, a person or victim's minor child or stepchild or minor child residing in the household, (2) the victim is under 10 years old, (3) the person used or attempted to use a weapon during the commission of the crime, or (4) the person had other previous convictions for certain crimes.

SB 616: Protection for pets in FAPA proceedings. Allows the court to grant, in the issuance of a FAPA restraining order, "other relief that the court considers necessary to...prevent the neglect and protect the safety of any service or therapy animal or any animal kept for personal protection or companionship."

**HB 3482:** Expands current workplace protections for victims of domestic violence, sexual assault, and stalking to victims of harassment. In addition the bill expands the types of documentation an employee may use to certify that s/he is a victim, to include evidence from and administrative agency.

**SB 293:** Expands current housing protections for victims to clarify that early lease termination provisions cover the victim as well as any immediate family members who are tenants.

### New Study of Jailhouse Phone Calls Reveal Insight into Why Domestic Violence Witnesses Recant.

A new study utilizing recorded telephone conversations between men charged with felony domestic violence and their victims hopes to reveal why some victims decide not to follow through on the charges. The researchers studied victims who had decided to recant listening to from 30-192 minutes of recorded conversations for each case.

They listened to and recorded telephone conversations between 17 accused male abusers in a Washington state detention facility and their female victims, all of whom decided to withdraw their accusations of abuse. Researchers analyzed up to three hours of phone conversations. The couples were aware of being recorded through an automated message at the beginning of each call. Such recordings have been approved by the state Supreme Court, and the researchers gained approval from the county prosecutor's office to use the recordings. All the recordings involved cases that had already been resolved.

After analyzing the calls, the researchers identified a fivestep process that went from the victims vigorously defending themselves in the phone calls to agreeing to a plan to recant their testimony against the accused abuser.

Stage one: Conversations include heated arguments between the couples, revolving around the event leading to the abuse charge. In these early conversations, the victim is strong, and resists the accused perpetrator's account of what happens.

Stage two: the perpetrator minimizes the abuse and tries to convince the victim that what happened wasn't that

serious. The perpetrator appeals to the victims' sympathy and cast himself as a victim. In one case, the accused perpetrator threatened suicide.

Stage Three: The accused abuser uses the sympathy of the victim, the couple bond over their love for each other and position themselves against others who 'don't understand them".

Stage four: Involves the perpetrator asking the victim to recant her accusations against him and the victim complying.

Stage five: The couple constructs the recantation plan and develops their stories.

The results of this study could help prosecutors and other victim advocates as they work with abuse victims in the criminal justice system. Findings challenge the existing belief that victims recant because the perpetrator threatens her with more violence.

Researchers highlight how emotion-based techniques of abusers may make it difficult for victims to disentangle themselves from violent relationships and encourage a model of advocacy that emphasizes victim education. The study recommends that Advocates counsel victims up front and let them know the sympathy appeals and minimization techniques that their husband or boyfriend is likely to use on them.
