MATCH FEDERAL FUNDS TO BUILD "MAX" SOUTH-NORTH LIGHT RAIL LINE

QUESTION: Shall district issue \$475 million of general obligation bonds to match federal funds to build South-North MAX light rail line? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of section 11b, Article XI of the Oregon Constitution.

SUMMARY: Plans to manage growth, clean air, reduce traffic, call for building a MAX light rail system. South-North MAX will serve Clackamas and Clark Counties, Portland, Vencouver. Each dollar of bonds is needed to get up to \$5 from Congress and the States of Washington and Oregon. No bonds will be sold unless Federal funds are approved. Bonds will mature in up to 30 years. Estimate of average year cost is 31 cents and highest year cost is 63 cents per \$1000 of assessed value.

EXPLANATORY STATEMENT

Official estimates state that the Portland metropolitan area will grown by an additional 500,000 people in the next 20 years. In the next five years, nearly 41,000 more cars will be added to our highways.

Regional plans call for the construction of a MAX light rail system to manage growth and maintain our quality of life. The plans count on light rail to help people move through the region in a way that protects air quality and reduces traffic.

Tri-Met opened the MAX light rail line from Gresham to downtown Portland in 1986. In 1990, voters approved local funds for a connecting MAX line from downtown Portland to Hillsboro. Construction of that line is underway. Together, these MAX lines will create a MAX light rail corridor that runs from east to west through the region.

Plans also call for a new 25 mile South/North MAX light rail line that will run from Clackamas County, through Portland, to Vancouver, Washington. It will connect with the east-west line, completing the backbone for our regional transit system.

The South/North MAX line will provide about 60,000 rides each day or 19 million trips each year. It will reduce air pollution by about 720 tons -- 1 1/2 million pounds -- each year. It will reduce rush-hourtrafficcongestion on the region's south-north freeways and bridges.

To provide the local funds for the South/North MAX light rail line, the Tri-Met board of Directors placed this measure on the ballot. The measure authorizes the sale of \$475 million in general obligation bonds to support construction of the line.

The financing program for the project calls for each \$1 of local funds to be matched by up to \$5 from the States of Oregon and Washington and the federal government.

By 1996 Congress is expected decide which light rail projects will receive federal funds. To get Congress to approve funds for the South/North MAX light rail line, local funds must first be approved.

That is why Tri-Met is asking now for voter approval of the South/North MAX bonds. No bonds will be sold, however, until federal funding is approved.

The bonds will mature in up to 30 years from the date of issue. Bonds will have an estimated average year cost of 31 cents per \$1000 of assessed value and an estimated highest year cost of 63 cents per \$1000 of assessed value.


