



### Unpacking the factors that influence homelessness

### Homelessness is a housing problem


The motivation for this book stemmed from the author's observations that the roots of the homelessness crisis in many cities in the U.S. were being misdiagnosed, often to frustrating and harmful ends. A public focus on mental health and drugs-certainly, important risk factors for homelessness-dominates narratives in the Puget Sound region, thereby narrowing the policy conversation. In discussions with stakeholders throughout the region, it became apparent that an intense focus on behavioral health might be masking a more important root cause of the crises: housing market conditions





### More than half of the rate of homelessness can be explained by rent level

A 2020 GAO report found that a \$100 increase in a region's median rent correlates to a 9% increase in its rate of homelessness.






### Factors that are largely unrelated to the homelessness rate

### Community rates of

- Serious mental illness
- Illicit drug abuse
- Substance use disorder
- January temperature
- Poverty rate
- SNAP or SSI caseloads

Are **not correlated** with higher rates of homelessness

# SHS goals and objectives

### SHS in the voter pamphlet

This measure will authorize Metro to establish a regional supportive housing funding program, providing the resources to address unmet housing needs of people experiencing or at risk of experiencing long term or frequent episodes of homelessness in the greater Portland region. The measure will result in a substantial increase in the delivery of supportive housing services.

### Supportive housing services: Addressing homelessness in greater Portland

Ten-year regional goals for the fund are:

- Connect at least 5,000 households experiencing homelessness to permanent supportive housing
- Stabilize at least 10,000 households at risk of or experiencing homelessness in permanent housing

SHS funds may be used for services that support these goals, such as outreach, shelter, housing search navigation and employment programs.





# Revenue picture

### Revenue

Supportive housing services will be funded by a marginal personal income tax of 1% on households with taxable income over \$200,000 (or taxable income over \$125,000 for individual tax filers) and a business profits tax of 1% with an exemption for small businesses that have gross receipts of \$5 million or less per year. The personal income tax will be assessed on residents of the Metro district, and on non-residents who have income earned from sources within the district. Only income above \$200,000 (\$125,000 individual) is taxed.

Cumulative Collections from August 2021 through February 2025




FY 2023 = \$343M This chart shows **cumulative**revenue collections by fiscal year.
With only 3.5 full years of collections,
there is limited history and points of
comparison.

In FY 2024-25 so far, revenue is trending lower than the prior year. However, the majority of revenue is collected in April and May, meaning that the revenue trajectory can shift significantly very late in the fiscal year.


These figures represent tax collections only, not including interest or other adjustments.

Metro updated its revenue recognition process in Summer 2023 to align with accrual accounting. As such, this chart shows historical collections with August as the first month of the fiscal year, since that reflects income earned in July.









# Key takeaways

### Takeaways

By 2023, SHS had become the largest single source of funding for targeted homelessness interventions in the Portland metro region.

A soon to be released report will show that its share of regional funding increased in 2024.



### Takeaways

Coincident with SHS's implementation, the region has seen a expansion of bed inventory—especially PSH, other permanent beds, and emergency shelter.



### Takeaways

The program's goals are activity based, rather than outcome based, and they almost certainly will be met or exceeded.



#### Takeaways

The dynamic and unpredictable nature of homeless spells makes targeting interventions inherently challenging. The science of targeting is in its early development.



#### The majority of unhoused people don't stay on the street. Many more are like Sarah.

#### Takeaways

The principal drivers of the region's homelessness crisis, housing scarcity and high rents, have not eased since SHS's implementation and could worsen in coming years.



#### Takeaways

An abrupt end of SHS in the early 2030s would eliminate the major source of targeted homelessness funding and put upward pressure on total and unsheltered homelessness.

#### **HMIS Background**


#### HMIS Data includes:

- ✓ Participant data
  ✓ Services data
- ✓ Housing data
- Data is collected during service interactions according to defined standards and contract requirements
  - HSD recently aligned and refined outcomes and output
- Counties perform data quality checks
- HMIS data is 'pulled' to create data reports and By-Name Lists



#### HMIS Background: What's a BNL?

HMIS Data is used to produce By Name List Reports including Snapshots of Who
is Actively Homeless by Population: Population A, Unsheltered, and All Homeless





#### **New Population and Services Data**

For the first time, we are showing:

- Monthly snapshot of who we understand to be homeless
  - Sheltered, Unsheltered, and location unknown
  - Inflow and Outflow to our By Name List
  - Demographics
  - Newly de-duplicated
- Improved (and some new) service data for Housing, Shelter, and Prevention
- Improved information on Chronic Homelessness



#### Why this Dashboard Matters

- Data-driven decisions lead to reductions in homelessness
- Data helps identify trends, track progress, and implement strategies
- This tool transforms raw data points into actionable insights to help make informed decisions toward effective interventions.
- By leveraging insights, our community will be better at creating lasting change and improving people's lives.



#### What Do We Expect

- Major milestone for our understanding of our community and the impact of our work
- With <u>increased services</u> and <u>improved</u> data collection, we expect to see an increase in our By-Name List
  - A sign of improved tracking, service reach, and data management
- Moving forward, changes in numbers are more easily understood to be real changes in lives

As efforts continue to expand outreach and provider participation, the By-Name data will become more comprehensive, most likely resulting in higher actively homeless numbers.

This increase doesn't mean that more people suddenly became homeless, but rather the system is better able to account for everyone who is experiencing homelessness across the community

## **Key Takeaways**

- People are moving off the list, but many remain
  - 5,502 people (48%) remain on the current list
  - 52% (5,928 people) are not on the February 2025 list
    - Matches our understanding of the numbers of people experiencing chronic homelessness
- Despite steady outflow to housing, inflow is outpacing outflow



## Key Takeaways (continued...)


- Despite year-over year progress in preventing more people from becoming homeless while housing and sheltering thousands – people are entering homelessness faster than people are returning to housing.
  - Housing shortage, lack of affordable housing; prices outpace wages.
  - Eviction cases statewide are the highest in over a decade.
  - Inflation has raised the price of rent, utilities, food, healthcare, and so many of our basic needs.
  - Other factors make people's circumstances or likelihood of becoming homeless worse, including the fentanyl crisis and the need for more readily available mental health assistance.




Who is chronically homeless in Multnomah County?










