

Part of the challenge is decreased state funding, but in fact this district has managed economic downsizing effectively. The real challenge is to get more from our other resources.

We are in a period of financial stability, we must use this opportunity to thoroughly review our current program; some recent changes merit close scrutiny. Thirteen years of community volunteer work convinces me that our best new ideas emerge by tapping the creative potential in all quarters. I want to create and promote an open, responsive system, which actively seeks and utilizes our parent, staff and community ideas.

We successfully teach our students creative thinking but must place stronger emphasis on clearly communicating their ideas.

Older students are commonly given early release from campus to save money, but not providing enough courses to keep them engaged is unacceptable. We must value teenagers more. I will work to identify volunteer opportunities for our students, crafting programs for them as tutors and/or interns.

We must protect inspiring classes for our motivated, college-bound students but also offer training to those students who do not plan to proceed immediately to universities. I will encourage closer relationships with our community colleges and private businesses to provide technical skills demanded by our local job market.

Challenging decisions require creativity, openness and positive working relationships between people and organizations. These are the qualities that I offer you as your school board representative.


