## <u>Diversity and Cultural Competency Award:</u>

John McVay has been an active member of the Department of Community Justice Cultural Competency Steering Committee for several years. In 2008, John became the first DCJ member of the Sexual Minorities Roundtable, a group of designees from local law enforcement agencies whose Mission is to improve relationships, respect, cooperation and crime reporting in the sexual minority community and to reduce the fear of law enforcement within that community. John is being recognized for the inclusion, equity and personal respect he demonstrates every day both on and off the job.

# <u>Employee Innovation Award (2 winners)</u>:

**James Still** is a Senior IT Development Analyst who wrote and implemented an application development starter kit that can effectively reduce the time it takes to develop business applications by 25-30%. James is constantly looking for ways to leverage technology to meet and exceed the needs of the County. His work on the application development starter kit is an excellent example of these efforts.

**The Clinical Systems Information (CSI) Training Tool Development Team** brought together staff from the Health Department and the Office of Information Technology to bring to fruition the Health Department's vision of an efficient, on-line training system for the Epic Electronic Medical Record and Practice Management system. The CSI Training Tool Development Team represents a stellar example of County innovation through an effective cross-departmental collaboration. ## Library Radio Frequency Identification (RFID) Conversion Project Team
