Logic Model

It was clarified that members should engage in the logic model discussion with the assumption that the outcomes refer to youth and families who are current and potential clients of the SUN Service System.

Using the outcomes recommended by the Task Force, members had a discussion that resulted in the creation of a draft logic model for the SUN Service System. This logic model is a work in progress and can be found on the website and has also been sent as an attachment to these notes.

Next Meeting

- May Cha will create a logic model chart based on the discussion and have it sent to workgroup members. She will also bring copies to the next meeting.
- The Department of County Human Services will pull together some existing definitions that are commonly used for each of the long-term outcomes identified at today's meeting. This will be brought to the next meeting.
- The agenda for the next meeting will include simplifying and editing the logic model and begin identifying services that contribute to the outcomes.
- There is a desire to invite other jurisdictional stakeholders to a meeting to provide input on the logic model (such as WSI, Stand for Children, City of Portland BHCD, and so forth). This could happen at the July 20th meeting.
