## **Program Description**

Multhomah County has a large number of people experiencing unsheltered homelessness who are living in places including vehicles, encampments and other places not meant for habitation. These individuals have lacked sufficient routine engagement with outreach workers to establish trust and become engaged in services they need to transition out of homelessness and back into permanent housing.

Program offers 30210A: Safety on the Streets - Navigation & Service Coordination and 30100: System Access, Assessment, & Navigation (30100) fund services focused on assisting people who remain unsheltered to meet their basic needs and navigate to shelter and housing. These programs are designed to reach folks who might not be accessing other services, and, as such, are intended to help reduce disparities in who is able to access homeless services. These programs include funding for outreach workers, who provide navigation and de-escalation services to people who are living unsheltered.

This program offer funds 2.00 FTE within the Homeless Services Department who provide contract management and Outreach Coordinated support. The Outreach Coordinator provides centralized coordination to outreach workers to support coordinated and equitable deployment of outreach across the County. The department Outreach Coordinator will work in partnership with the jurisdictional partners and nonprofit service providers, to help outreach workers better support people living in places including vehicles, encampments and other places not meant for habitation. In FY 2026, these two FTE will support a Countywide review of outreach services, as directed by the County Chief Operating Officer.
