Commissioner Judy Shiprack called the meeting to order. Minutes from the May, 2012 meeting were approved.

Appreciations

The Executive Committee recognized Congresswoman Suzanne Bonamici for her contribution to LPSCC as a member of the Executive Committee from 2008 until 2011 when she was elected to represent Oregon's First Congressional District in Washington, DC. Ryan Mann and Abby Tibbs from Congresswoman Bonamici's office accepted a plaque on her behalf. The Executive Committee also recognized Public Safety Applications Manager Elise Nicholson for her work supporting the research and analytical capacity of LPSCC.Elise retires July 1, 2012.

Old Business: Public Safety Budget Coordination

Peter Ozanne gave an update on the public safety budget coordination process. Many LPSCC members are in agreement about the need for intergovernmental budget planning and have committed to working on a long term process under the auspices of LPSCC.

Diane McKeel asked what level of involvement was anticipated by agencies outside of the City of Portland. Peter Ozanne and others noted that public safety issues are increasingly moving eastwards and Commissioner Shiprack and others agreed that it is important for east Multnomah County to be represented and engaged in the discussions.

Request for Support for Proposal to Byrne Criminal Justice Innovation Training and Technical Assistance Program

Deputy District Attorney Jim Hayden requested LPSCC's support for a proposal to the Byrne Criminal Justice Innovation Training and Technical Assistance Program. The proposed grant would support a public/private partnership connecting gang members and other at risk youth with positive role models through the 11:45 group. It also focuses law enforcement resources in the Albina neighborhood and puts into place geographic exclusions for regular street disorder by misdemeanor probationers identified as gang affiliated. The grant identifies LPSCC as a research partner. There being no objection to a letter of support from LPSCC, Peter Ozanne agreed to work with Jim Hayden to produce one for the grant proposal.

Multnomah County Schools Exclusionary Discipline Report

Karen Gray, Superintendent of Parkrose School District and LPSCC Executive Committee member, presented on the Multnomah County Schools Exclusionary Discipline Report. The report examines data from 2009-2010 and concludes that students of color are disproportionately subject to disciplinary actions resulting in suspension and expulsion, especially for offenses that are defined more subjectively. The Executive Committee discussed current responses to the issues presented in the report, including Restorative Justice at Parkrose Middle School; Elevate Oregon, a culturally specific program for African American students at Parkrose High School; truancy court; and trainings such as Courageous Conversations.

Multnomah County Public Safety Data

LPSCC Public Safety Analyst Matt O'Keefe distributed a proposal for an analysis of fugitive arrests, a category that makes up a substantial number of average daily arrests but represents a variety of different case types. He will present the data analysis at the July 2012 LPSCC Executive Committee meeting.
