Steering Committee members began by each sharing "one small success" – something in their work or life that has gone well recently.

STRYVE Grant

Rebecca Stavenjord provided an update on the STRYVE grant. Fifteen of nineteen million dollars has been restored to the Federal violence prevention budget and full funding is anticipated for STYVE. Staffing for STRYVE will include three part-time positions: A youth organizer and two community organizers. They hope to be able to introduce the staff to the Steering Committee at the next meeting. Antoinette Edwards, Samantha Kahn, Roberta Phillip and Rebecca Stavenjord recently attended a grantee's meeting in Atlanta.

The STRYVE team has created two ad hoc work groups. Members of the Youth & Gang Violence Steering Committee are invited to join either if they wish. They should contact Rebecca if they are interested.

Samantha Kahn presented an overview of the STRYVE evaluation and assessment process. They will utilize a MAPP process – Mobilizing for Action through Planning and Partnerships. STRYVE activities are currently moving into the Community Capacity Assessment phase, and the CDC has provided tools to conduct this. Samantha and others will be mapping community assets, and this information will provide the basis for strategies based on existing strengths. There is not an abundance of "best available evidence" so this will be a demonstration site.

Rebecca and Samantha led the group in a discussion and visioning exercise exploring the questions: "What does it look like to prevent youth violence?" and "What do you hope to see as a result of STRYVE in 1, 5 and 10 years?" They will provide a summary of this discussion at the February 27th, 2012 meeting of the Youth & Gang Violence Steering Committee.
