Program Description

This program addresses the critical need for supportive housing in Multhomah County. This is described in the Local Implementation Plan (LIP) for Supportive Housing Services (SHS). Specifically, it targets the following issues:

The overall shortage of permanent supportive housing for individuals experiencing or at risk of chronic and episodic homelessness. The LIP aims to create over 2,235 supportive housing units in ten years.

Racial disparities within the homeless population. The LIP prioritizes eliminating these disparities.

The need for wrap-around services to support individuals in maintaining their housing and improving their well-being.

This program offer funds the supportive services and long-term rental assistance needed to create 200 new supportive housing units. This will include a mix of site-based and tenant-based supportive housing. In site-based supportive housing, the supportive services and rental assistance are connected to a particular building or complex. In tenant-based supportive housing, the rental assistance is provided to the individual or family, not tied to a specific unit. This allows participants to search for housing in the private market. All 200 supportive housing units are intended for Metro priority populations, with a specific focus on Black, Indigenous, and other People of Color (BIPOC) households experiencing or at imminent risk of chronic homelessness.

The intended outcomes include:

Increased permanent housing options for chronically homeless individuals and families.

Reduced racial disparities in homelessness.

Improved housing stability and overall well-being for program participants through access to supportive services.

The program provides: Funding for support services Site-based and tenant-based rental subsidies Specialized services tailored to various subpopulations
