### Announcements and Updates

#### **East County**

The District Attorney's office is spending more resources in Mid and East County. Deputy District Attorney Nathan Vasquez will now be working as part of the DA's gang unit out of the Gresham Police Station. The Neighborhood Unit, where Vasquez was previously housed, will continue efforts in East County with new resources.

#### **Information Sharing**

A proposal for the information sharing policy is in the process of being prepared by Deena Corso, Commander Kevin Modica, Abbey Stamp, and Lauren Brown. The proposal will be presented at a future Youth & Gang Violence Subcommittee and once approved by the subcommittee, to the LPSCC Executive Committee.

### OJJDP Comprehensive Gang Model

Consultant Lore Joplin presented an overview of the OJJDP Comprehensive Gang Assessment Model. The model is designed to build collaboration, assess the youth gang problem, identify goal and prioritize activities, develop an implementation plan, and implement activities and system structures to reduce youth gang problems. The model has five strategies for addressing gang involved youth: community mobilization, opportunities provision, social intervention, suppression, and organizational change and development.

The model is divided into three phases: assessment, planning, and implementation. The first phase is assessment which defines the problem. It was recommended that The Youth and Gang Violence Subcommittee comprise the core of the steering committee that oversees the assessment phase. A data workgroup focused on quantitative analysis and a survey workgroup focused on qualitative analysis will conduct the assessment. The assessment phase should be completed by summer 2014.

During the planning phase the data from the assessment is used to clarify and prioritize gang related problems, develop measurable goals, and identify activities designed to achieve the goals. The second phase should be completed by October 2014. The final phase is the implementation of the plan to address youth gang activity.

The subcommittee discussed the OJJDP assessment plan and gave support for conducting the assessment. The subcommittee chairs will bring this recommendation to the LPSCC Executive Committee in January.
