Introductions, Announcements, and Approval of Minutes

Co-chair Judy Shiprack called the meeting to order.

The minutes of the November 5th, 2013 LPSCC Executive Meeting were approved.

OJJDP Comprehensive Gang Assessment

Christian McMahan presented an overview of the OJJDP Gang Assessment Model on behalf of the Youth and Gang Violence Subcommittee. A consultant, Lore Joplin, provided a scope of work plan for the assessment. The model is broken into three phases: assessment, implementation planning,

and implementation. The assessment will identify the nature and scope of the Youth and Gang Violence problem in Multnomah County. A framework for addressing the problem will be developed during the planning phase and implemented during the final phase. The goal is to complete the assessment phase by the end of the fiscal year. Veterans Court

Judge Julie Frantz and Ginger Martin presented the Multnomah County Veterans Outreach Project and Probation Violation Docket. A Memorandum of Understanding was presented including objectives, eligibility, and the roles of each partner agency in the project. Self-identified veterans who are determined eligible can opt to participate. Corrections Health Update

Nancy Griffith, Director of Corrections Health, gave an update on Corrections Health. Corrections Health had hired staff to enroll individuals who go through the jail in the Affordable Care Act. Once enrolled, these individuals will need education on how to use the health care system.

Justice Reinvestment Update

Lily Yamamoto, the Justice Reinvestment Project Manager, was introduced. An Operations Group had been put together including a team of Data Analysts. The group is exploring evidence based assessment tools that could be used during the sorting process. The data analysts are working to support the operations group by collecting recidivism data and helping identify a target population for the justice reinvestment project.

Legislative Update

Nancy Bennett and State Representative Jennifer Williamson gave a legislative update. There will be a one-month legislative session in February. Potential issues to be addressed during the session include the budget, the Youth Development Council's funding proposal, restoration of the reduction to the maximum length of incarceration for technical violations, marijuana, and privatization of liquor sales.

Patrick Sieng from the Association of Oregon Counties is working to restore funding for liquor law related enforcement and to allow dependents of deceased reserve law enforcement officers access to the same benefits as other officers' dependents.
