## **MEETING MINUTES**

#### **Welcome and Introductions**

Resources for Supporting Military Connected Children and Youth Sarah Johnson	Sarah presented an overview of the Oregon National Guard's Child and Youth Program and provided county-level data on the number of children with a parent in the Guard. With the most recent data (2012) in Multnomah County there were 192 children between the ages of 0-5 years, 208 children between ages 6-12, and 165 children ages 13-17 with a parent in the Oregon National Guard, for a total of 565 children in the county.  The three staff members in this program serve around ten thousand kids across the state, which Sarah described and distributed packets with additional information on the military teen panel, family camps, the free tutor.com resource for families of current service members and wounded warriors, and graphics on the stages of deployment.  Suggested ways that schools can help:  • Be aware and track kids who have a parent in the military  • Be aware of where that parent is at in the deployment cycle  • Contact the Child and Youth Program to build a custom program to promote understanding of community needs and staff development goals  • Encourage military-connected children to participate in the tutor.com program  Discussion:  • Logical partnership with the county's foster grandparent program, and information about these resources will be added to newsletters.  • Discussion about upcoming event to support healing and resilience through fishing called "celebration of wild steelhead". A few years ago there were 305 HUD-VASH housing vouchers for

chronically homeless veterans allocated to Multnomah County. These vouchers are limited to paying for rent, so local partners formed "Operation 305" to overcome barriers and ensure that all the vouchers were used. In this partnership, Home Forward provided reports on voucher usage and can cover the security deposits for veterans, the VA sped up its hiring process for case workers and improved accessibility with services available at the CRRC, the county (with other entities) provided flexible funds to help veterans pay for housing costs, and Home Forward along with multiple nonprofit housing organizations used networks with landlords to help veterans get housed. All of the VASH vouchers are leased up now. A team from the local area recently went to Washington, DC, on a conference to end veteran homelessness as part of the "25 cities initiative". Building on this initiative, they looked at data and estimate 424 chronically homeless veterans that need to be housed by the end of 2014 to accomplish this goal.

### Operation 424 to End Veteran Homelessness

Seth Lyon, Carolyn Bateson, Sally Erickson Housing programs used in "Operation 424" include HUD-VASH, SSVF, Grants and Per Diem, and Shelter + Care. In addition, an estimated 15% (about 64) of chronically homeless veterans are not eligible for VA services and will be housed through other local programs.

Goal of Operation 424 is to house 100 by Veterans Day this year (14 per month), and the other 324 by the end of 2014 (at a rate of 23 per month). Thus far there have been 72 housed since April, 2013.

Using values-based approach that emphasizes a "no wrong door" philosophy where any veteran can access help from any point in the system, and housing first model where individuals are housed and then receive the necessary supports to keep them successful in that placement. The three key issues to address are: 1) finding a safe place off the streets until a unit opens up, 2) Finding a housing placement, and 3) Retention to keep that veteran in the apartment.

Carolyn described the positive impact that these strong community partnerships has helped make possible.

Asks for the Task Force:

- Carry forward the message to the community that there is hope for ending homelessness among veterans and the successes of Operation 424. If you know a homeless veteran, please send them to the Community Resource Referral Center, Transition Projects, or a County Veteran's Service Officer.
- 2) Legislative advocacy to enable flexibility for HUD-VASH funds (e.g. 5% that could be used for other housing-related costs).

## 3 to PhD Initiative

Kevin Matheny, Julie Dodge, Jen McCalley Kevin and Jen presented an overview of Faubion Elementary, Concordia University, and the shared facility and partnership between the two. Faubion Elementary, which sits adjacent to the Concordia campus, has a large boundary area stretching as far as Jantzen Beach, eighty-one percent of students are on free & reduced lunch, and approximately twenty percent are homeless. Due to food insecurity at home and students who ride the bus as long as an hour or more each way, the school provides breakfast, snack, and lunch for students, as well as supper for those participating in SUN school programming.

Concordia has over 9,000 students, about 2,000 of whom are undergraduates. One primary focus is its education programs, which include a Masters in Education and newly started Education Doctorate program.

In 2012 a bond passed for Portland Public Schools and after an extensive fundraising campaign by Concordia they will break ground on a new school in about February of 2016. The new building will house Faubion classrooms as well as Concordia's 3 to PhD classrooms, extensive wraparound services for students, three science/tech/engineering/arts/ math (STEAM) classrooms, a full-time social worker, and professors and college students integrated into school programs. Reviewed sketches of the conceptual layout for this new building for discussed how the services and academic programs are integrated in.
