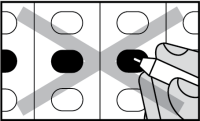
Use a blue or black pen.



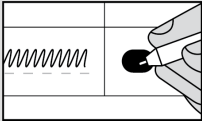
Rank candidates in the order of your choice.
