Transportation System Plan // What is a TSP?

What is a TSP?

- Provides Counties, Cities, and States with guidance for operating and improving a multimodal transportation system
- Focuses on priority projects, policies, and programs for the next 20 years
- Provides a vision for longer term projects that could be implemented, should funding become available
- Guides development review decisions, CIP programming, and efforts to obtain grant fund
- Intended to be flexible to respond to changing community needs and revenue sources over the next 20 years and will be updated approximately every 10 years



Transportation System Plan // Plan Development Process

Plan Development Process

- Review plans and policies
 - Document existing plans, policies, and ordinances applicable to the study area that pertain to the TSP update
- Evaluate existing conditions
 - Inventory and evaluate all modes, users, and infrastructure of the transportation system
 - Identify existing deficiencies
- Future baseline conditions
 - Evaluate future no-build land-use and transportation conditions
 - Identify future deficiencies



Transportation System Plan // Plan Development Process

- Plan Development Process (Continued)
 - Policy Review
 - Audit existing policies and update, remove, and identify new policy needs
 - Alternatives Analysis
 - Develop alternatives to address system deficiencies identified in the existing and future conditions analysis
 - Evaluate the alternatives; determine preferred alternative
 - Prioritize improvements
 - Policies, Ordinances, and Financially Constrained Plan
 - Report proposed policies, ordinances, and financially constrained plan for inclusion in the TSP
 - TSP
 - Must be approved and adopted



Existing & Future Conditions Memo // Existing Conditions

Existing Conditions

- Primary issue in rural areas is safety
- Low-cost systemic treatments may be effective on County facilities
- Despite the lack of shoulder bikeways, many of the County's rural roadways are popular cycling routes.
- Most county roads lack shoulders which increase safety and provide mobility for all modes (cars, trucks, agricultural equipment, bicycles, and pedestrians)



Existing & Future Conditions Memo // Future Conditions

Future Conditions

- Population and employment in the rural areas is expected to grow at approximately 3 – 3.5 percent per year
- Multnomah County has several different plans that identify transportation improvements in the County's rural unincorporated areas
- Capital Improvement Plan identifies recent priorities
- Bicycle Master Plan identifies desired network for bicycles



Key TSP Topics //

- Prioritizing Safety Improvements
 - What should be considered in prioritizing safety improvements such as widening shoulders?
- Existing Bicycle Master Plan Routes
 - Are they still valid?
- Alternatives Analysis
 - What areas do you see that need a solution?
 - Primarily a prioritization effort
