

Together with Kaiser & Moda, the Benefits & Wellness Office is offering on-site flu shot clinics to employees, as part of the County's overall efforts to promote healthy, supportive worksites.

#### The Clinics are Easy and Convenient.

30 clinics over two weeks—*Oct. 5-16*—in worksites across the county. Flip over for the schedule.

#### All Employees are Eligible.

No cost to employees covered by Kaiser or Moda.

# IMPORTANT: Bring your insurance ID card or mobile app!

#### Not enrolled in a County Health Plan?

You are still eligible if you opt-out, or your position is parttime, temporary, or on-call.

- Pay \$26, cash or check.
- You'll receive a receipt and the cost may be reimbursable by your health plan or healthcare reimbursement account.

#### The County will Pay for Your Time to Get Your Shot.

This includes time to travel to and from the clinic.

• You must talk to your supervisor to arrange coverage.

#### Go mobile! It's easy!

#### Kaiser:

Register or sign-in at <u>www.kp.org</u>. Download the Kaiser Permanente Mobile App or get it from your app store. Sign on. Tap the green card icon at the bottom of the app dashboard screen.

#### Moda:

Go to your app store and install the Moda Health eCard. Launch the App by entering your mobile PIN code and subscriber ID. You'll find your PIN code on your PDF card at <u>www.myModa.com</u>.

• If needed, you can go to a clinic in another building, unless it is secure and you don't have access to that building. Secure buildings are marked \* on the schedule.

#### What to Bring:

Wear a shirt with short sleeves or sleeves that can be rolled up to your shoulder.

Bring proof of insurance: 1) Kaiser or Moda ID card, 2) mobile app, or 3) insurance ID number and County badge. You will have to call Kaiser or Moda if you don't bring proof of insurance, causing longer wait times.
