### **Welcome, Introductions and Announcements**

Antoinette Edwards opened the meeting and introductions were made.

- Roberta Phillip was introduced as the new Youth and Gang Violence Prevention Specialist, and she gave a brief overview of what she would be doing.
- There will be a Kids at Hope event on Wednesday, July 7<sup>th</sup> at 9am.
- There will not be a Community Peace Collaborative meeting on July 3<sup>rd</sup>.
- The US Attorney's Office has submitted several requests to DOJ related to the Smart on Crime initiative. Hope to report the results at next meeting.
- Defending Childhood has been working with Reynolds School District to start a Trauma Informed Care breakthrough series.
- Erika Pruitt mentioned a Community Empowerment conference that takes place in Minnesota, which addresses trauma in the black community. DCJ hopes to bring a similar conference to Portland in January 2016.
- Julia Mitchell said she has a new compliance officer role at POIC and will still be involved with community outreach.
- Promise Zone debrief—our jurisdiction received a high score for crime need and government collaborations.

- Boys and Girls Club is serving more kids than last year.
- Summer Works is on track to serve 750 kids this summer.
- The past two weekends have been a little quieter for the Gang Enforcement Team.
- Multnomah County received the MacArthur Safety and Justice Challenge grant to make a plan for reducing the number of people in jail. The county is focusing on options for inmates with behavioral health needs, decreasing the disproportionate incarceration of people of color, and decreasing the number of low-level inmates in jail.
- Brian Detman and Sang Dao met with Multnomah County youth at OYA's Camp Florence to share Comprehensive Gang Assessment updates. The importance of relationships was reinforced.

## Overview of Work Done Since the Last Meeting

The Coordinating Council and a subgroup of the Coordinating Council did more narrowing of the strategies. The updated document was distributed. The format has been changed to an objective statement followed by 3 strategies per theme.

The *Disconnection from Schools* strategy will be renamed *Connection to Schools*. Before going further with this strategy, Abbey Stamp will be in contact with schools with plans to go to them. It was noted there is 2 million dollar United Way Initiative to reduce disproportionate discipline in schools.

Before going further with the *Links Between Police*, *Youth & Communities* strategy, a meeting with all local law enforcement agencies is needed.

Three of the almost-final strategies were looked at through the lens of Who Benefits and Who Doesn't. The following are the results from a large group discussion:
