Executive Summary

A Home for Everyone (AHFE) is a joint jurisdictional initiative addressing homelessness in the county. AHFE includes emergency homeless services such as Safety Off the Street, Emergency Shelter and Housing Placement for families and unaccompanied youth experiencing homelessness. This offer is a placeholder for the future consolidated lead agency.

Program Summary

As part of the joint A Home for Everyone (AHFE) initiative the jurisdictional partners -- Multnomah County, the City of Portland, the City of Gresham and Home Forward -- have recommended consolidating homeless services and contracting into a single lead agency entity. A consolidated lead agency is anticipated to improve homeless services by creating a single point of contact for all homeless services, including housing all program staff in the same location, creating joint budgeting, shared outcomes and accountability, and shared contracting and outcomes.
