We are looking for someone who is excited to work with Elections Division. This position will directly support the Voter Education and Outreach Program assisting the program specialist in voter education activities, outreach events, data collection, and research. The successful candidate will also have the opportunity to experience a wide range of elections processes. The internship will occur during one of our most active times, between the May primary election and November general election in 2016.

## This position will have an emphasis in the following duties:

- Work with the Elections Division team, in particular the Voter Education and Outreach Program Specialist to develop, plan, organize, attend, present and evaluate outreach events and voter education programs across the county for a wide range of diverse audiences.
- Work with the program specialist to perform designated research and data collection regarding county demographics and voter and resident experience in Multhomah County.
- Work with the program specialist to conduct community leader and organizational staff interviews. Attend community meetings and organizational events.
- Write small informative pieces for specific audiences on social media and other diverse media platforms. Assist the Communications team.
- Assist with research and drafting of the Voter Education and Outreach Plan for FY17.
- As part of this experience, the intern will gain experience in many aspects of elections processes both directly related to community outreach and elections operations overall.

## Education and Experience:

We are looking for someone who has the following knowledge, skills and abilities:

- Ability to work independently with minimal supervision as well as the ability to collaborate within a team environment.
- Communication skills, both listening and speaking. Ability to communicate clearly in both oral and written formats. Willing to ask questions.
- Good self-management and organizational skills. Must be able to meet deadlines and arrive to work and events on time.
- Interested in doing presentations, holding workshops, and tabling events. Comfortable speaking in public.
- Interested in learning more about elections and civic engagement. Desire to engage with underrepresented communities to increase voter participation and civic involvement.
- Desire to learn more about and interact in cultures and communities unlike their own.
- Working knowledge of Google applications (Docs, Drive, Slides, etc.) or Microsoft (Word, PowerPoint, etc.).
- An application must be submitted along with a current resume and a one page cover letter telling us why you are applying for this particular internship supporting the Voter Education and Outreach Program in Elections. Your cover letter will both demonstrate your writing skills and tell us what you are hoping to learn from this experience.

- Multilingual in English and at least one other language including but not limited to Chinese, Russian, Spanish, Vietnamese and Somali.
- Two or more years of college experience at the start of internship, preferably in related field.
- Familiarity and general knowledge of Multnomah County geography and the communities that live here.
