Introductions, Announcements, and Approval of Minutes

Introductions were made.

The December meeting minutes were approved.

Judge Nan Waller announced the court analyst position has been posted.

Commissioner Diane McKeel noted the CSEC bill is doing well in Salem.

Commissioner Judy Shiprack noted the US Supreme Court's opinion on juvenile life without parole, which fit with the screening of the film *Resilience*.

Criminal Justice Commission (CJC) Presentations

CJC's Director Mike Schmidt congratulated LPSCC for the What Works 2016 conference.

Mike Schmidt introduced the <u>Oregon Knowledge Bank (OKB)</u> which comes from HB3194 to promote the use of evidence-based practices and cost-effective programs. The OKB is a resource for the public safety community in Oregon with a focus on policing, corrections, and community supervision programs; research conducted on criminal justice initiatives; and public safety agency profiles.

Serving Public Safety Agencies in Multnomah County Ross Caldwell gave an update on statewide and county-by-county prison use. It was noted that prison forecasts do not factor in Justice Reinvestment programs or Family Alternative Sentencing Programs. See the <u>presentation</u> for details.

District Attorney Rod Underhill reminded the group of forecast variables; Economists included population growth but the intake rate is going down relative to historic practice.

Judge Edward Jones asked about jail capacity county-by-county. There has not been a statewide survey yet, but CJC will look in to it.

CJC reviewed the reduction goal <u>dashboard</u>. If there were 25 fewer male and 6 fewer female intakes per month statewide, Junction City and having to use all of Deer Ridge could be avoided.

Federal Criminal Justice Grants

Multhomah County grants coordinator Sheri Campbell created a document to track upcoming federal criminal justice grants. Sheri is available to help departments be competitive and apply.

LPSCC Year in Review

Abbey Stamp reviewed LPSCC's 2015 work. Major topics included the Safety and Justice Challenge; Juvenile Justice including Racial & Ethnic Disparities data, Trauma Informed Care inventory, and the OJJDP Gang Assessment; Justice Reinvestment; the Mental Health Subcommittee; the DSS-J.

Abbey is working on the year-end report.
