## Introductions, Announcements, and Approval of Minutes

Introductions were made.

Annoucements:

- Miriam Green, DHS Child Welfare, is retiring and Kellie Barber will represent DHS at LPSCC
- The LPSCC May Minutes were approved.
- Abbey Stamp noted the LPSCC executive meeting structure will be changing. Some meetings, starting on July 12<sup>th</sup>, will be the smaller LPSCC leadership meeting. The larger LPSCC meeting will still take place several times a year.

## **Domestic Violence and Gun Dispossession**

Traci Anderson of the Multnomah County District Attorney's Office presented information about the presence of a firearm in a household and the relation to domestic violence (DV) and homicides of intimate partners. The DA's office has taken a collaborative approach to the problem to develop a program and legislation. There are mechanisms in place to stop violent DV offenders from possessing firearms. The MOU and a new Senate Bill 525 gun law are tools for protecting DV survivors and children. The April

Serving Public Safety Agencies in Multnomah County 2016 audit showed that 92 guns were removed from offenders. Defendant truthfulness is the biggest gap. See the <u>presentation</u> for details.

Follow-up questions:

- Judge Waller asked whether there were restraining orders in place for DV homicides in 2015. Traci will find this information and pass it on.
- Mike Reese noted Gresham is not a party on the MOU. Traci will look for what percentage of domestic violence cases take place in Gresham.

# **Domestic Violence and Public Safety**

The Honorable Judge McKnight presented public safety issues related to domestic violence in Multnomah County, which included five types of protection orders, reporting and entry of law enforcement data, assessment, and batters' intervention programs. The presentation concluded with "As a community we lack an imperative and resources for adequate assessment." See the <u>Power Point</u> for more information.

Commissioner Shiprack asked for data on what percentage of homicides are DV. This could be a future focus for LPSCC.

# **OJJDP Safe Thriving Communities Grant Application**

Erin Fairchild gave an overview of the Defending Childhood Initiative (DCI). The county is eligible for the OJJDP Safe Thriving Communities Grant, which will support countywide efforts to create and implement a comprehensive and collaborative approach to violence prevention by aligning existing county and city-led programs and infusing them with authentic community voice. LPSCC will act as the convening body, creating a new Violence Prevention Coordination Team accountable to the existing LPSCC Youth & Gang Violence Subcommittee.

Erin will provide a template to LPSCC partners for letters of support.

# 2017 Public Safety Budget

Commissioner Shiprack shared jail bed reduction is a major priority. There is funding for a nurse at Booking; a Multnomah County LEAD program; and improvement of the DSSJ data warehouse. Commissioner Shiprack noted we need to address racial and ethnic disparities in the system. A budget note requires the Relative Rate Index (RRI) be reported to LPSCC twice a year.
