Introductions, Announcements, and Approval of Minutes

The November LPSCC minutes were approved.

Judge Nan Waller noted the 2nd judicial listening session is Thursday, November 3rd.

Abbey Stamp announced there will be a "Hands Up" production sponsored by LPSCC and The MacArthur Foundation on Friday, November 4th.

It was decided to keep the January 3, 2017 LPSCC meeting on the same date.

Commissioner Judy Shiprack was honored for her years of LPSCC and public safety leadership.

Medication Aided Treatment

Sheriff Mike Reese noted he and Chief Deputy Mike Shults recently traveled to Denver to learn more about addiction treatment in jails.

A significant number of people come to jail with addiction. Dr. Michael Seale, Corrections Health, reviewed the current response to opioid addiction in jails. Alison Noice, CODA Inc., talked about treatment option opportunities and noted one challenge is that treatment drugs have different regulations. CODA reaches in to jails to improve the re-entry process. Medication aided treatment in jail is important in treatment retention. Our system should make improvements to not interrupt medication aided treatment. A warm handoff at the moment of release is also critical.

Joanne Fuller recommended reducing barriers to prescribing treatment medications should be a federal agenda item. Insurance coverage for people while in jail is also a federal issue; currently funding comes from the county general fund.

DA Rod Underhill was concerned the treatment needs are not being communicated to prosecutors, defenders, and the bench.

Jail Capacity Management Plan

The current Jail Capacity Management Plan was written in 2010 when there were 1310 jail beds. The new jail bed capacity is 1251, so the population management plan needs to be revised. An emergency population release (EPR) is deployed when capacity reaches 95%. A 90% yellow light/early warning system is one option.

One current strategy to manage the jail population numbers is 1201 Releases (12:01am people are released when the jail is at capacity.) Another is 9503 (transfers are put in transport area so they are not counted.)

Decisions:

- The yellow light warning system should be included in the resolution.
- The 1201 releases is an undesirable strategy. If there are other options, it may be taken out of the resolution.

The meeting was adjourned.
