 DOCUMENTATION STATUS WON'T BE REPORTED

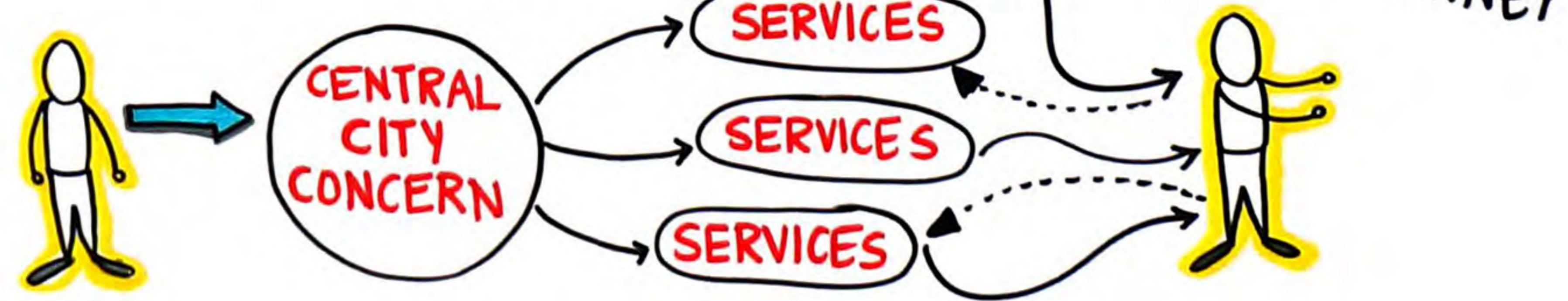
FUNDS AVAILABLE FOR PEOPLE WITHOUT INSURANCE...
