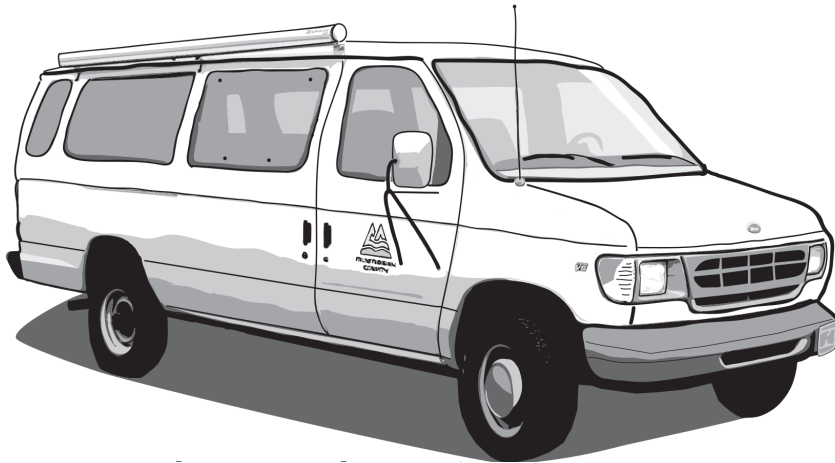

Oregon has a Good Samaritan Overdose Law!

If someone is overdosing and you seek medical help, neither of you can be arrested or prosecuted for:

1. Possessing drugs or drug paraphernalia
2. Being in a place where drugs are used
3. Violating probation or parole because of #1 or #2
4. Outstanding warrants related to #1 or #2

Please call 911

Ask needle exchange staff how you can get naloxone. Refills are available for clients who received training. Replace your overdose kit if you lose it or use it!

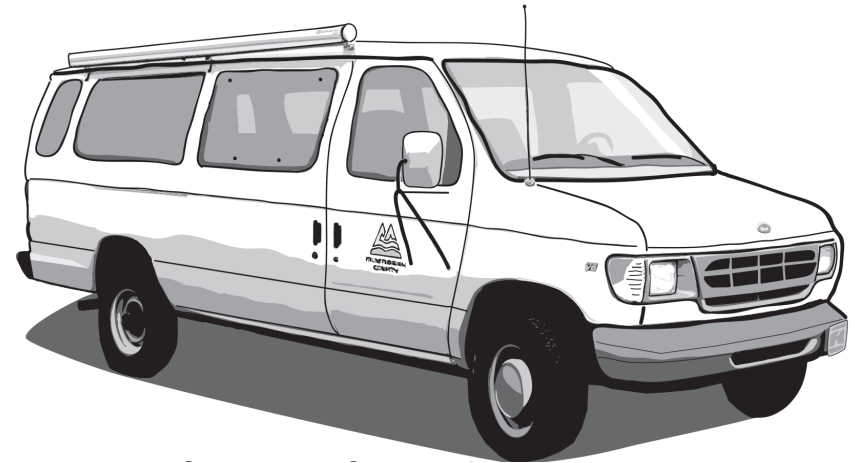
