#### **Introductions and Announcements**

Antoinette Edwards opened the meeting and introductions were made.

PPB's James Dakin announced due to an increase in shootings in November, PPB conducted a focused mission where 40 people were arrested and 10 guns were seized. Shootings drastically declined in December.

Eric Zimmerman, MCDA, announced federal funding for witness support across Oregon.

Mary Geelan announced the court will have a 3rd judicial listening session on Thursday, January 12<sup>th</sup>.

Brian Detman announced there will be a presentation by Judge Nan Waller about JDAI at Donald E Long on January 12<sup>th</sup> at noon.

#### **Discuss Funding Request Priorities**

Staffing: Mary Geelan has been coordinating the gang assessment process on a part-time basis and will continue until February 2017. There may be an OJJDP grant opportunity for a coordinator. Until then, LPSCC's Lily Yamamoto will be able to contribute some time for coordination through June. The February 13<sup>th</sup> LPSCC meeting will feature the Gang Assessment Implementation Plan and there will be asks for agency resources.

The draft of the Multnomah County Gang Assessment Implementation Plan Activity Overview was reviewed and discussed with a focus on funding needs.
