Introductions and Announcements

There was an icebreaker and introductions were made.

LPSCC Executive Committee Update

Abbey Stamp provided a brief history of the OJJDP Multnomah County Comprehensive Gang Assessment process to date. The [implementation plan](#) was presented at February's LPSCC Executive Committee meeting. Comments and observations about the meeting were shared. It was agreed the momentum can continue if LPSCC is presented with implantation updates.

Phase 2 Reflections and Phase 3 Implementation

An implementation team will be formed. Lily Yamamoto will help facilitate and coordinate through June 2017. Leadership for the activities will be: Joe Walsh on Coordinated Entry; Kevin Modica on Links Between Police, Youth & Communities; Joe McFerrin/POIC on Employment Opportunities; Antoinette Edwards and Erin Fairchild on Connection to Schools; CHI and POIC on Parent Partnerships. Antoinette will follow up with Nathaniel Williams about Mentorship. Julia Mitchell and Eric Zimmerman will join the mentorship group.

There was discussion about reach-in activities in the jails and the best name for this work to keep community and business partners engaged. Mary noted the Frameworks Network, which helps with messaging and naming.

Abbey Stamp gave an overview of the [Law Enforcement Assisted Diversion \(LEAD\)](#). The pilot program launched on Tuesday. A [KBOO interview](#) will air on March 6th.

Lily Yamamoto noted there will be a meet & greet on March 15th at 3:30pm with the National Gang Center researchers.

Antoinette invited the group to present the implementation plan to the leaders of Portland Public Schools. Deidra will work on involving East County Schools.

There is an exhibit at IFCC called "Kin Killin' Kin," which addresses violence against/within the African American community.

The Black Student Success Summit is Saturday, April 15th.

Vanessa Micale announced the OHSU community forum on gun violence is on April 22nd. STRYVE sent out an invitation to an event about understanding violence as a public health problem.

The MCSO has a program to reduce gun violence and is working on training and information about handling/storing firearms.

The Latino Network is helping families get legal documentation ready in case of deportation event.

Mary Geelan noted people can file a restraining order at the Gateway One-Stop Center in lieu of going to the courthouse.

On April 5th there will be a rally in Salem to draw attention to preventing child abuse.

Christina will share the list of leads for the implantation workgroups.
