Introductions and Announcements

Introductions were made and people said their name how they want to hear their name.

Impact Justice and the Burns Institute

Alice Perry introduced Malachi Garza from the Burns Institute. Malachi noted the Burns Institute's efforts to reduce Racial and Ethnic Disparities (RED) through community participation. The work includes engaging 5 jurisdictions to show outcomes to create evidence-based practices for community-based organizations.

- ❖ Malachi will forward a roster of programs and initiatives.

Updates and Information Sharing

Law Enforcement Update: There have been 8 shootings, including 1 this morning that is related to the May homicide in Beaverton. There was discussion about a funeral happening tomorrow at the same time as the Grand Jury for a homicide last week.

- ❖ Vanessa Micale requested this group have space to share information about ICE activities.

- ❖ Erin Fairchild suggested LPSCC and the Y&GV Subcommittee make a statement about how some of the Federal Administration's immigrant policies decrease public safety.
- ❖ There was discussion about inviting ICE and Homeland Security Experts to exchange dialogue around policies and what the community is experiencing. Perhaps someone from ACLU and immigration attorneys could also attend. Suzanne Hayden has contacts. Antoinette will follow up with Alice and Suzanne.

DA Updates:

- The grand jury for last week's homicide is taking place on Friday.
- The 9 year old who was shot: there are 2 people indicted in connection, and there will be more to come.
 - Commissioner Stegman and Antoinette Edwards prepared a statement that will be coming out in the Oregonian.

Measure 11 Survey

Babak introduced several youth from STRYVE who are conducting a student-led [survey](#) about reforming or repealing Ballot Measure 11, which resulted from the interest at a judicial listening session. There was discussion about some of the misinformation in the survey and about disparities.

- ❖ Antoinette invited the group to come back and share the results.

Erin Fairchild gave an update on the federal grant the Defending Childhood Initiative (DCI) received.

Strategy #5 update: Michelle Barrows-Carter noted the work on the Juvenile Justice Handbook for families.
