Neighborhood Inspections enforces Title 29, the Property Maintenance Code of the City of Portland. This Code is designed and was passed by City Council to reflect the wishes of the neighborhood and the goals of Portlanders. This Code covers the maintenance of residential dwellings, accessory structures and the land on which they sit. This Title is set up to establish and enforce minimum standards only. Codes are enforced through incremental enforcement. More than just formal enforcement, inspectors and staff provide education and referrals to assist the homeowner toward the common goal of better housing. In the event of non-compliance this department is set up with tools to gain compliance. It is important to note that while primary efforts are toward public safety, part of the mission is the protection of property and contributions to neighborhood livability.
