Introductions, Announcements, and Approval of Minutes

Introductions were made.

The December minutes were approved.

Judge Bushong noted several new judges will join the bench soon.

Abbey Stamp noted the What Works Conference will no longer be held in conjunction with the Justice Reinvestment Summit. In 2019, the What Works focus may be forensic-responsive addictions treatment again with the Health Care and Judiciary Committees in Salem.

Rod Underhill noted testing of the backlog of SAFE Kits is nearly complete. Remaining grant funds will be used to test SAFE kits in other Oregon counties.

Multnomah County State Legislative Agenda 2018

Jeston Black and Rosa Klein of County Government Affairs presented an overview of the legislative session, county priorities, important issues in health, human services, public safety, sustainability, and transportation. County priorities are:

- Protect County Safety Net Programs
- Take Action on Housing and Homelessness
- Fund Behavioral Health

Prevent Gun Violence

The short sessions begins February 5th. See the presentation for details.

Other legislative priorities include:

District Attorney's Office:

- The DA's office is working on a legislative fix to help with convictions for auto theft.
- HB5006 deals with dependency court funding. MCDA feels this is the wrong direction for Multnomah County.
- Lack of clarity for funding of SB505, which deals with Grand Jury. Multnomah County is a pilot.

Sheriff's Office:

Priorities include gun violence reduction efforts to close loopholes.

There is a need for an IGA around ODOT and homeless sites. The policies should be county-wide.

Courts:

The Courts took a large budget cut, so one priority is to get some of the funding restored. Judge Bushong will report back on the budget-reduction committee's decision.

The Sheriff's Office has hired an outside consultant to look at better ways of doing business at court.

MHASD could potentially offer an outpatient treatment pilot program. The Chair's Office will convene a group.
