Executive Summary

The Family Independence Initiative (FII) creates opportunities for families to thrive through self-driven activities and social networks. This offer continues an FII pilot which begun in FY2018 by continuing to support families already engaged in the program and to fully understand the impacts of this innovative model begun through the pilot.

Program Summary

ISSUE: Social service programs often operate from a needs, or deficit, focus by offering ready-made solutions for individuals and families who are experiencing poverty. These strategies overlook the creative ways in which families achieve their goals and the strength of communities to lift people into prosperity. Emerging research demonstrates that when families work from their strengths to create their own support networks, share resources and provide mutual support to one another, they can move toward their goals for economic and social mobility.

PROGRAM GOALS: The goal of the Family Independence Initiative (FII) is for families to use resources they identify and share rather than relying on pre-determined social service resources. The Initiative reinforces that each family knows its own most effective pathway to general well-being, providing an invitation and trusted space to pursue that path and create a series of steps to empowerment and autonomy.

PROGRAM ACTIVITY: The Department will continue the contract with the Family Independence Initiative, a national nonprofit that offers results-based and participant-driven solutions to increasing economic and social mobility. FII creates an environment where families come together, empower themselves and are trusted to improve their lives, in their own way. As families take initiative, they gain access to resources that can accelerate their efforts. By providing a structure and a robust data platform, FII creates a strategy that is family-owned with a data feedback loop and opportunities to thrive toward economic prosperity. As the contractor, FII provides technical assistance, guidance, and operational support to facilitate the continuation of this Pilot project in Multnomah County.
