This position will directly support the Voter Education and Outreach Program (multco.us/education-and-outreach) under the supervision and direction of the program specialist assisting in voter education activities, outreach events, data collection, and research. The successful candidate will also have the opportunity to experience a wide range of elections processes.

### This position will have an emphasis in the following duties:

 Work as part of the Elections Division team, and under the direction and guidance of the Voter Education and Outreach Program Specialist to develop, plan, organize, attend, present and evaluate outreach events and voter education programs across the county for diverse audiences.

- Work under the direction of the program specialist to perform designated research and data collection regarding county demographics and voter and resident experience in Multnomah County.
- Work under the direction of the program specialist to conduct community leader and organizational staff meetings.
- Attend community meetings and organizational events.
- Have the opportunity to write small informative pieces for specific audiences on social media and other diverse media platforms.
- Assist the Communications team.
- Assist with research to guide future work of the Voter Education and Outreach Program.
- As part of this experience, the Program Technician will gain knowledge in many aspects of
  elections processes both directly related to community outreach and also to elections
  operations overall.

#### **Education and Experience:**

We are looking for a candidate who has the following knowledge, skills and abilities:

- Ability to work independently with minimal supervision as well as the ability to collaborate within a team environment.
- Communication skills, both listening and speaking. Ability to communicate clearly in both oral and written formats. Willing to ask questions.
- Good self-management and organizational skills. Must be able to meet deadlines and arrive to work and events on time.
- Interested in doing presentations, holding workshops, and tabling events. Comfortable speaking in public.
- Interested in learning more about elections, voting, and civic engagement. Desire to engage with underrepresented communities to increase voter participation and civic involvement.
- Desire to take an equity focused approach to remove barriers to voter access and ensure every voice has the opportunity to be heard. Will have the opportunity to learn about equity and inclusion in public service work.
- Desire to learn more about and interact in cultures and communities unlike their own.
