#### Cross-System Inter-professional Care Coordination Now and in the Future



If you are new to care coordination, or just want to take this opportunity to focus on the basics, make sure to attend these discussions and workgroups. This track features speakers from a wide range of companies who are at the forefront of care coordination across the Portland Metro Area.

#### Inter-disciplinary Teams in Action 1

Panel discussion with Amanda Hernandez MSW, CSWA, CADC1, MH Practitioner, IHART Team, Central City Concern Community Engagement Program & D'Anne O'Neill, MSW, LCSW, Social Work Supervisor, Providence ElderPlace. Discussion topics include a person-centered and culturally responsive care with example cases.

#### Shaping Meaningful Care Coordination for the Limited English Proficiency Population

An interactive workshop with Toc Soneoulay-Gillespie, MSW, Population Health Social Services Manager at CareOregon. Facilitator will use a participatory approach to explore how providers and interpreters, together, impact power, privilege, and access to communication and information.

#### Practice Cross-system Care Coordination

Small groups will address care coordination needs/challenges in case vignettes to answer questions such as: who takes the lead when working accross systems, how to determine who needs to be a part of the care team and what is the relationship between the individual/patient and the different care coordinators on the team.
