## **RESOLUTION NO. 2019-067**

Establishing Fees and Charges for Chapter 13 of the Multhomah County Code Relating to Animal Control and Repealing Resolution No. 2017-054.

### The Multnomah County Board of Commissioners Finds:

- a. Chapter 13, Animal Control, of the Multnomah County Code provides that the Board will establish certain fees and charges by resolution.
- b. On June 22, 2017, the Board adopted Resolution 2017-054 establishing fees for MCC Chapter 13.
- c. The Board wishes to increase license fees for pet licensing, facility licensing, boarding fees and adoption fees, as shown in the chart below.
- d. Multnomah County Animal Services has conducted a comparison analysis with other jurisdictions in the region and found a need to increase these fees to bring them in-line with current market rates.

### The Multnomah County Board of Commissioners Resolves:

**1.** The fees and charges for Chapter 13, Animal Control, of the Multnomah County Code are set as follows:

<u>Section 13.004:</u> SPAYING AND NEUTERING ENCOURAGED.

The amount set aside by the Board from revenue generated from pet licensing to cover the cost of the county's public educational, spaying and neutering programs is \$25,000.
