BALLOT TITLE

Bonds for Safety Improvements, Seismic Renovations and Operational Efficiencies

Question: Shall Corbett School District renovate, save operating costs and improve safety by issuing \$15 million in general obligation bonds? If the bonds are approved. they will be payable from taxes on property or property ownership that are not subject to the limits of sections11 and 11b, Article XI of the Oregon Constitution.

Summary: If approved, District would renovate/replace buildings to reduce maintenance costs, replace old plumbing, electrical, and heating/ventilation systems; meet building codes for seismic, fire and life safety; improve safety and traffic flows and comply with federal ADA and educational equity laws.

This measure is expected to:

- Make seismic and fire protection upgrades to the Multipurpose Cafeteria, Old Gym and High School. Replace seismically challenged Middle School to
- improve safety. Renovate 1970 Gym; add classrooms and second multi-purpose facility.
- Construct new Bus Barn.
- Acquire land with building to save construction costs; make improvements if Board determines to be cost effective.
- Furnish, equip and make site improvements for all projects; pay for demolition and costs of issuance.
- Excess proceeds could be used to contribute to track construction. Private funds would also be solicited.

Bonds would mature in a period not to exceed twenty-six years. The initial tax rate is estimated to be approximately \$2.29 per \$1000 of assessed property value, an estimated increase of nine cents per \$1000 of assessed value from the 2012-2013 rate.

EXPLANATORY STATEMENT

The last significant investment in Corbett School facilities occurred in 1994 when voters passed a \$6.5 million bond to construct a new elementary school.

In January 2013, the District appointed a diverse group of Corbett citizens who, along with professional architects, engineers and construction experts studied facility needs. Community meetings gathered feedback from the general public and Corbett voters were surveyed about different

Except for the elementary school, District buildings are between 35 and 90 years old. Since their original construction, building codes have been updated to reflect new requirements for fire and life safety and earthquake resistance. The Middle School (1923) is constructed almost entirely of hollow clay tiles and classified as "dangerous" according to building codes.

The Middle School and Old Gym have been maintained, but do not contain energy-efficient mechanical, electrical and plumbing systems that could save on operating costs and protect the community's investment.

With the expiration of the 1994 bond, and a lower interest rate climate, a new \$15 million bond would cost an estimated \$2.29 per thousand of assessed value. If this new bond were approved, property taxpayers in the Corbett School district are estimated to see an increase in their property tax rate attributable to schools of nine cents per thousand of assessed value above the rate paid in 2012-2013. This is an estimate only.

With a new bond, the District would renovate buildings to reduce maintenance costs; replace old plumbing, electrical, and heating/ventilation systems; meet building codes for seismic, fire and life safety; improve campus safety and traffic flows and comply with federal ADA and educational equity

Specifically, the bond is expected to:

- Make seismic and fire protection upgrades to the Multipurpose Cafeteria (1970), Old (1954) Gym and High School (1977) to improve safety and security.
- Replace the seismically challenged Middle School with an energy-efficient building to increase safety and save
- money on operating costs.
 Renovate the Gym Addition (1970) to increase energy efficiency and improve safety, add classrooms and a larger multi-purpose facility to complement the smaller auditorium in the Multipurpose Cafeteria.
- Furnish, equip and make site improvements for all projects; pay for demolition and costs of issuance.
- Acquire nearby land, with building, that would save construction costs in the replacement for the Middle School and make improvements to this property if the Board determines them to be cost effective.
- Construct a new Bus Barn that would improve the safety of students and staff, ease traffic congestion and save operating costs.
- Use some bond proceeds to leverage any additional available state funding for seismic and energy efficiency projects.

If proceeds remain after the above projects are completed, the District would consider using a portion to contribute to the construction of a new track. Private funds would also be solicited for this purpose.

A citizen bond oversight committee would be appointed by the School Board to ensure that bond proceeds are spent properly and only on projects described in the ballot title and explanatory statement.

ARGUMENT IN FAVOR

Since Corbett's earliest days, our community has made student learning a priority by investing in a high quality public education delivered in safe, well-built facilities.

The last significant investment in our school buildings occurred in 1994 with the construction of the Elementary School. The remaining facilities are between 35 and 90 years old. Their mechanical and electrical systems, plumbing and heating systems, are no longer energy efficient and cost the District ten of thousands of dollars to operate – money that could be used to improve instructional opportunities for students.

Our current Middle School has served the community well but is now classified as "dangerous" according to the building code. With the current low interest rates, we can replace this building with a safer, more energy-efficient structure that honors the current building's design elements, but gives students a modern learning environment for the next century.

Our gyms and multi-purpose building can be made more accessible and safer for students and staff, as well as for the larger community who frequently use them.

A new construction bond will help our small school district support exceptional educational opportunities that we can choose to share, on our own terms, with students from nearby communities. But we will never accept too many out-of-district students that we sacrifice what makes Corbett special: small classes, a rigorous curriculum and creative teachers who know every student by name and who are committed to helping them develop their full potential.

Corbett is being recognized for the excellence of its educational program. Our students are graduating into well-paying jobs. Many go on to complete college; all are on their way to becoming good citizens.

Our students deserve to learn in safe, cost-efficient facilities that prepare them for their world of tomorrow – whether they find that world here in Corbett or somewhere else.

ARGUMENT IN FAVOR

I am a lifelong Corbett resident from a fourth generation Corbett family and a 1975 graduate of Corbett High School. Two of my children recently graduated from Corbett and two are still in high school. I am 33-year member of Multnomah Co. Fire District #14 (17 years as Fire Chief) and have responded to many fire and medical calls in Corbett school buildings over the years.

As a firefighter, I know the limitations of older buildings with regards to fire and life safety issues. Only three of our buildings are protected by sprinkler systems. The fire alarm systems in our older buildings need updating. The current Middle School has corridors that are not constructed of firerated materials; it and other buildings are not compliant with the Americans with Disabilities Act (ADA). Protecting the safety of our students, staff and visitors, and the community's investment in our buildings -- the largest capital investment of Corbett taxpayers -- are crucial aspects of the bond measure.

I received a quality education from Corbett schools, one that helped prepare me for a career as a professional electrician. However, with today's ever changing technology the current Middle School is also outdated. Outdated electrical, heating and ventilation systems increase utility costs compared to modern, energy saving systems. Replacing mechanical systems can save significant dollars in operating costs, dollars that can be put to use in the classroom. Our students today are once again receiving a high quality education. They deserve buildings that can deliver programs -- including science, technology, math and engineering - that give them the same choices I had in the jobs and careers of tomorrow.

Our community has the opportunity to re-commit to our schools -- maintaining and strengthening the original investment of earlier generations of Corbett families – an investment that is critical to the future of our community and the success of our students.

In addition to teaching math in Oregon public schools for ten years, I was also a Corbett business owner between 1983 and 2009. I have served on the boards of numerous Corbett school, church and community organizations and have always encouraged the education of young people.

Ninety years ago the present high school (Columbian HS) was built because the original school burned down. Let's do the responsible thing and build a safe, modern school building before another disaster happens with possible injury to our children

The bond will be well administered by professional school planners and by our own District staff who have made CHS one of the top schools in the nation. These same professionals saw that the Springdale school remodel was done successfully: in one summer and within budget.

Improved facilities -- safer, more energy efficient and designed for a modern education -- will enable the District to continue to use the extra operational funds generated from charter and transfer students to support our great teachers who are preparing Corbett children for college and our present world.

With refurbished buildings, the Corbett school system can stay small, but it can't be just for in-district only students: not enough revenue would come from the State to hire teachers for even the minimal educational requirements, and the school would lose its accreditation. In the process, we would lose what we value most about our community. My old Columbian HS building needs to be replaced with a new, safe and modern Corbett High School. I fully support a new school bond and I hope you will, too. Please vote YES.

ARGUMENT IN FAVOR

I've been a Corbett resident since 1979, when my family moved here from Troutdale. In 1986, I graduated from Corbett HS and had the privilege to be the National Honors Society president. At the time, it didn't seem much of an honor to be part of this group, because the standards were not as challenging as today. But I appreciate my high school experience because of the uniqueness of Corbett.

After living in Texas, Oklahoma and Jamaica, I transitioned back home to Corbett. Stacey and I are raising three daughters in the house that we plan to call home for the rest of our lives. When we bought our home, we had no idea that the school just up the road had transitioned into one of the best in the state, and the nation. What used to be ordinary is now extraordinary.

Five years as a District 14 firefighter showed me the power of transition. A month after I joined the fire department we took ownership of a new rescue vehicle. The old rescue had served the community well, but it was time to upgrade. Today, that new vehicle is the most frequently used one in the fleet and I can't remember any member saying how much they miss the old 65

As I watched my daughters and the staff make the 1923 Middle School work, I marveled at their ingenuity. But the simple fact is that that building has outlived its capacity to serve our kids and the kids that will come after them.

Our community needs facilities that support the excellence that is happening in the classroom. With the low interest rates currently available, we can replace this building, and greatly improve our Gym, Multi-Purpose Building and High School with only a small increase in our taxes. This transition is also a bargain, too.

ARGUMENT IN OPPOSITION

The results of the *Nelson Community Survey, July 2, 2013*, show that the Corbett residents would support a bond for a new middle school, seismic upgrades to the existing gym and multipurpose building. These projects total 8.1 million. Instead, the vote (5-2) by the School Board was to place a bond on the ballot for 15 million, for dreams of grand sports fields, fitness center, theater, among other elaborate unnecessary projects.

It was explained by board members that they're asking to spend 15 million but that how they spend it would be finalized later. In essence they want a blank check after which they will decide without any required input of the community whatsoever which projects will or won't be included.

The Nelson survey indicated that the community would be likely to support a measure if the out of area students would not increase with the bond passing. The plans presented illustrate building a new school with double the classrooms of the existing building and additionally include plans to purchase a 14,000 square foot building that is for sale near the main campus (ServPro) as the new district office, which in reality is only the superintendent and two secretaries.

Our student population has doubled since 2009. Over half of the students do not live in Corbett. There has been no independent analysis of our resident population growth potential. Our tax payers are being asked to not only embrace the continual expansion of our schools but also to now pay the hill

No one is opposing the replacement of the middle school or the safety and seismic upgrades needed.

It has been said if it fails in November they will re-evaluate and go again for the May election. We the people can force a more responsible plan and reasonable amount if we so choose!



Tips for voting

- Read the ballot, envelope and voters' pamphlet carefully
- To ensure your vote counts, completely fill in the oval to the left of the response of your choice. Please use a black or blue ink pen.
- If you make a mistake or change your mind while marking your ballot, you may request a replacement ballot from the Elections Office or you may make your changes on the ballot, but it is critical that you make your choice obvious because election workers will inspect each ballot to make sure voter intent is understood and the ballot is counted correctly. Make your intent clear.
- Do not put multiple ballots in one envelope.
- The secrecy envelope is not required. If you forget to enclose the secrecy envelope your ballot will still count.
- Don't forget to sign your return envelope. Your ballot will not count if you do not sign the return envelope.
- If you accidently sign another member of your households return envelope just cross off your signature and sign the correct one. The other member can then sign their envelope and vote.
