Wages have not kept up with inflation. We are in crisis in OR. My Father's House has 30 units for families who can stay for up to 6 months. Training on employment and obtaining permanent housing is provided. Rockwood is a 244 unit complex. There will be some ADA apartments and they will have 1-4

		 bedrooms. Half of the units will be on a sliding fee scale, no section 8 will be taken. Grace - We do not have enough housing units. Short term sleeping pods and tiny homes are solutions. Land needs to be obtained to put them on. The mayor of Hillsboro read Grace's article and is hoping to implement some of the ideas. Education of the public on homeless and the issues is needed. Mike - Change is needed in the way we view the homeless situation. Mental health is a huge contributor to the homeless situation. Art - Gresham had a task force, but the people who were living with homelessness were not at the table. This committee happened over two years ago and there has been no reports. This work is hard, what are we asking this committee to do? Barb - Infrastructure is needed. Hygiene, garbage pickup, and not sweeping camps is needed. Barb has lived experience with all of these things. We need to make sure to give the dignity that all people deserve. She
